INFRASTRUCTURE FUNDING AGREEMENT

Board staff will be starting the process for the Infrastructure Funding Agreement in November with the first three steps: Identify all comprehensive and affiliated/specialized centers in the local area, identify the partners engaged in or through each center, and identify how each partner provides services/access in each center/in the system. Board staff will be reaching out to Core Partners to set up meetings.

IN-SERVICES

Discussed feedback from the October In-service Day: location worked out well, enjoyed the interactive activities, and Jon Klaus' presentation was great. Started planning for the February In-service Day, Monday, February 19, 2024. The Ottumwa and Marshalltown offices will do separate meetings but will work together on the agenda. Some of the topics/ideas for the agenda were: timelines from all programs of what's upcoming, best practices for each office, employer tour, include chamber of commerce/economic development, have a panel of individuals served and how to improve services, refugee resettlement agency, and Iowa Department of Cultural Affairs.
